The candidates are required to produce –

- 1) Copy of online application form;
- 2) Bio-data Form;
- 3) Attestation Form;
- 4) Two passport size photographs (unsigned & unattested)
- 5) Certificate of enrollment under Bar Council of India/State Bar Council;
- 6) H.S.C. certificate in support of declaration of age issued by the concerned Board/Council;
- 7) Bachelor's Degree in Law (LL.B.);
- 8) At least 02 years of experience certificate as practicing Advocate;
- 9) Odia pass certificate;
- 10) Caste certificate in original;
- 11) PwD certificate whenever applicable;
- 12) If a Sports Person certificate issued by the Director of Sports Odisha;
- 13) Identity proof, any document.

Mere participation in the document verification does not reserve any right to appear the Viva Voce test. The candidates shall be allowed to the Viva Voce test on scheduled date and time mentioned below subject to fulfillment of their eligibility in all respect as per verification of original certificate/ documents. The decision of the Commission thereon shall be final.

Guidelines for candidates in view of Covid-19

- a) Covid-19 test report (RT-PCR) showing “**negative**” (-ve) obtained from authorized laboratories of ICMR with **72 hours** of the date of document verification to be brought by all candidates. No candidate shall be permitted for document verification and Viva Voce test, **if Negative RT-PCR report not furnished.**

- b) The candidates should bring their own water bottles.
- c) Each candidate should carry his/her own sanitizer bottle and wear mask properly. No candidates shall be permitted to the document verification & Viva Voce test without proper masking.
- d) Each candidate should maintain social distancing norm of 6 feet while coming to the verification process & Viva Voce test.
- e) No candidate would be accompanied by any guardian or parent, Entry to the premises will be for candidates only.
